



Provincial & Regal Cabinet Acrylic Spas Limited Warranty

Provincial Spa Cabinet: 5 year structural

Evolution™ Spas warrants the original retail purchaser the integrity of the spa's cabinet, pillar supports and floor base from defects in material or workmanship for a period of 5 years. (repair or replacement)

Spa Surface: 5 years

Evolution™ Spas warrants the original retail purchaser the surface integrity of the spa against blistering or delaminating as a result of defects in material or workmanship for a period of 5 years. (repair or replacement)

Plumbing & Equipment: 2 years

Evolution™ Spas warrants the original retail purchaser the integrity of the spas plumbing against leaks as a result of defects in material or workmanship for a period of 2 years on parts and 2 years on labor. Evolution™ Spas warrants the original retail purchaser the integrity of the spa's Equipment Pack (pumps, heater, control system) to be free from defects in material and workmanship for a period of 2 years on parts and 2 years on labor from the original date of purchase.

Ozonators, LED lighting, and Sound System (where applicable):

Evolution™ Spas warrants the original retail purchaser that the factory installed ozonators will not malfunction due to defects in workmanship for a period of 1 year from the date of the original retail purchase. Evolution™ Spas warrants the original retail purchaser that the factory installed LED Lighting System will have a 1 year warranty to be free from defects in workmanship and materials from the date of the original retail purchase. Evolution™ Spas warrants the original retail purchaser that the factory installed sound system will have a 90 day warranty to be free from defects in workmanship and materials from the date of the original retail purchase.

Please Note: Electrical Connections must be made by a qualified, licensed residential electrician. Improper installations present hazards which can result in personal injury or property damage and void the warranty on the spa. Please see the Pre-delivery Guide and/or Owners Manual for additional information.

Exclusions:

This limited warranty is enforceable only by the original retail purchaser. Fuses, covers, light bulbs, light lenses, spa pillows, seals on pump and motor; and any dealer installed accessories are specifically excluded from this limited warranty.

All warranties are null and void if any of the following occur:

- The spa has been subject to alteration, neglect, misuse or abuse.
- Any damages caused by failure to install, maintain, and operate the spa in accordance with the recommendations contained in Evolution™ Spas Owner's Manual.
- Any and all costs of spa's removal and replacement including but not limited to removal and transportation, damages to landscaping, house structures.
- The spa has been used in a non-residential application or an application in which it was not designed.
- Spa shell damage caused by excessive heat build-up due to failure to cover the spa while empty of water and/or exposure to direct sunlight.
- Any damages caused by improper maintenance of spa water chemistry or by any undissolved spa chemicals which may cause bleaching of the spa shell and erosion or discoloration of stainless jets.
- Any repairs that are done by any one other than authorized Evolution™ Spas agent, or anyone without expressed written permission by Evolution™ Spas warranty department.
- Do not use third-party salt-based systems in your spa! Damage caused by salt-based systems that have not been factory installed will not be covered under your warranty.

IMPORTANT: Evolution™ Spas Warranty is void if the spa is moved to any location that is not the original 'Ship To' address.
